# FEE-HELP information About FEE-HELP

Students eligible for FEE-HELP can borrow up to a lifetime limit (indexed each year).

## **FEE-HELP eligibility**

FEE-HELP is available to:

- Australian citizens;
- New Zealand citizens;
- Permanent humanitarian visa holders residing in Australia for the duration of their studies;
- Permanent residency visa holders enrolled in units as bridging study for overseas trained professionals (BOTPLS) and residing in Australia for the duration of their studies

You must maintain a 50% pass rate to remain eligible for FEEHELP once you have completed eight or more units.

# **Applying for FEE-HELP**

You must complete your paper FEE-HELP application form before the Close of Enrolment date for the study term, or your enrolment will be cancelled.

# Commonwealth Assistance Notice (CAN)

If you have used FEE-HELP to cover all or part of your unit fees, then a Commonwealth Assistance Notice (CAN) will be issued within 28 days after the Census date. All students who are Commonwealth supported and/or who request HELP can access their CAN through My Study Centre.

A CAN is a statement containing information about your enrolment and use of Commonwealth funding assistance (FEEHELP). Higher education providers must issue a CAN to each of their Commonwealth assisted students after the Census date.
